

NOTICE OF PROPOSALS

Denbighshire County Council (Various Roads Denbighshire)

(Revocation of 20mph Zones, 20mph Speed Restrictions, 30mph Speed Restrictions) and

(Creation of 20mph Speed Restrictions on various lengths of roads in Denbighshire)

Denbighshire County Council hereby gives notice that it proposes to make an Order under Section 84 of the Road Traffic Regulation Act 1984, and of all enabling powers, the effect of which will be:-

1. To revoke the existing Speed Restriction Orders listed below which will revert to restricted road status.

This is due to the Welsh Government default 20 mph speed restriction implemented from September 17th 2023 across Wales and those Orders no longer being required, and Restricted Road status as defined by Section 82 of the Act will therefore be returned on the lengths of roads contained within these Orders:-

- The County of Clwyd (Princes Street, Rhyl) (20m.p.h. speed limit) (No 5) Order 1993
- The County Council of Clwyd (Kings Avenue and Oxford Grove, Rhyl) (20M.P.H. Speed Limit) Order 1996
- DENBIGHSHIRE COUNTY COUNCIL (B5119 GRANGE ROAD RHYL) (VARIABLE SPEED RESTRICTION) ORDER 2007
- DENBIGHSHIRE COUNTY COUNCIL (SPRUCE AVENUE AND ADJOINING ROADS RHYL) (20 MPH SPEED RESTRICTION) ORDER 2010
- DENBIGHSHIRE COUNTY COUNCIL (VARIOUS ROADS RHYL, LLANGOLLEN & CYNWYD) (20MPH SPEED RESTRICTION) ORDER 2017

3. To create 20 mph speed restriction orders on the lengths of roads listed below.

- A543 St Brigids A543; from the northern boundary of the Pumping Station, in a southerly direction to the first existing lighting column (approximately 14 metres from the centre of the St Brigids School entrance, in a southerly direction)
- Ysgol Bro Famau, Llanarmon yn Ial Unclassified Road outside Ysgol Bro Famau, Llanarmon yn Ial; between a point 15 metres south of its most southern boundary of the school in a northerly direction to its most eastern boundary

- Ysgol Llanbedr DC, Llanbedr Road; between a point 33 metres north of the projected northern kerblines of the schools' northern vehicular access, and to point 127 metres south of the projected northern kerblines of the schools' northern vehicular access.
- Ysgol Pentre Celyn, Pentre Celyn - B5429; between a point 98 metres south of the southern boundary of the schools' vehicular access to its intersection with unclassified road - Old Farmhouse to Derwen Llanerch - Ruthin
