

# **Denbighshire County Council (Various Roads Denbighshire) (Revocation of 20 mph Zones, 20 mph Speed Restrictions, 30 mph Speed Restrictions) and (Creation of 20 mph Speed Restrictions) Order 2025**

Denbighshire County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1) and (2) and 2(1) to (3) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

## **Section 1 – Preliminary**

This Order shall come into operation of the XXX day of YYY 2025 and may be cited as the Denbighshire County Council (Various Roads Denbighshire) (Revocation of 20mph Zones, 20mph Speed Restrictions, 30mph Speed Restrictions) and (Creation of 20mph Speed Restrictions on various lengths of roads in Denbighshire) order 2025

# **Creation of 20mph Speed Restrictions (various roads)**

## **Order 2025**

The Orders listed in Schedule 1 to this order are hereby revoked on the lengths of road covered by the aforementioned orders and thereby have restricted road status.

The Orders previously made by Denbighshire County Council listed in Schedule 2 are revoked

No person shall cause any vehicle to travel at a speed in excess of 20mph on the lengths of road specified in Schedule 3

The Provisions of Schedule 3 shall not apply to any vehicle on any occasion when it is being used for ambulance service, fire service, or police purposes if the observance of that provision would be likely to hinder the use of the vehicle for the purpose which it being used on that occasion.

In so far as any provision of this Order conflicts with a provision which is contained in an Order made or having effect as if made under the Act, and existing when this Order comes in to operation, the provisions of this Order shall prevail.

In this Order except where the context otherwise requires, "motor vehicle" has the same meaning as in Section 136 of the Act.

3. No person shall cause any vehicle to travel at a speed in excess of 20mph on the lengths of road specified in Schedule 3 below

### Schedule 3

- **A543 St Brigids A543**; from the northern boundary of the Pumping Station, in a southerly direction to the first existing lighting column (approximately 14 metres from the centre of the St Brigids School entrance, in a southerly direction)
- **Ysgol Bro Famau, Llanarmon yn Ial** Unclassified Road outside Ysgol Bro Famau, Llanarmon yn Ial; between a point 15 metres south of its most southern boundary of the school in a northerly direction to its most eastern boundary
- **Ysgol Llanbedr DC**, Llanbedr Road; between a point 33 metres north of the projected northern kerblines of the schools northern vehicular access, and to point 127 metres south of the projected northern kerblines of the schools northern vehicular access.
- **Ysgol Pentre Celyn**, Pentre Celyn - B5429; between a point 98 metres south of the southern boundary of the southern schools' vehicular access to its intersection with unclassified road - Old Farmhouse to Derwen Llanerch - Ruthin
